ACCIDENT WAIVER AND RELEASE OF LIABILITY

I acknowledge that fishing and boating is a dangerous activity and carries with it the potential for death, serious injury and property loss. The risks include, but are not limited to; those caused by terrain, bodies of water, motorized and non-motorized vessels, facilities, temperature, weather, equipment, actions of other people including, but not limited to, participants, and/or producers of the activity. I hereby assume all of the risks of participating in this excursion. I realize that liability may arise from negligence or carelessness on the part of the persons or entities being released, from dangerous or defective equipment or property owned, maintained or controlled by them or because of their possible liability without fault.

I certify that I am in good health, have sufficiently prepared to be a participant in this excursion and have not been advised otherwise by a qualified medical person.

I acknowledge that this Accident Waiver and Release of Liability (AWRL) form will be used by employees and guides of Small Stream Outfitters, activity organizers and sponsors, in which I may participate and that it will govern my actions and responsibilities at said excursion.

In consideration of my application and permitting me to participate in this excursion, I hereby take action for myself, my executors, administrators, heirs, next of kin, successors, and assigns as follows: (A) Waive, Release and Discharge Small Stream Outfitters, their owners, employees, volunteers, agents, sponsors, permit grantors, property owners, and event participants, from any and all liability for my death, disability, personal injury, property damage, property theft, lost income, or any other losses, costs or actions of any kind which hereafter may accrue to me by virtue of my preparation for this excursion, my participation in this excursion or my travel to or from this excursion; (B) Indemnify and Hold Harmless the entities or persons mentioned in this paragraph from any and all liabilities or claims made by other individuals or entities as a result of any of my actions during this excursion.

I understand that at this event or related activities, I may be photographed, I agree to allow my photo, video or film likeness to be used for any legitimate purpose by the employees and guides of Small Stream Outfitters, producers, sponsors, organizers and/or assigns. The AWRL shall be construed broadly to provide a release and waiver to the maximum extent permissible under applicable law.
